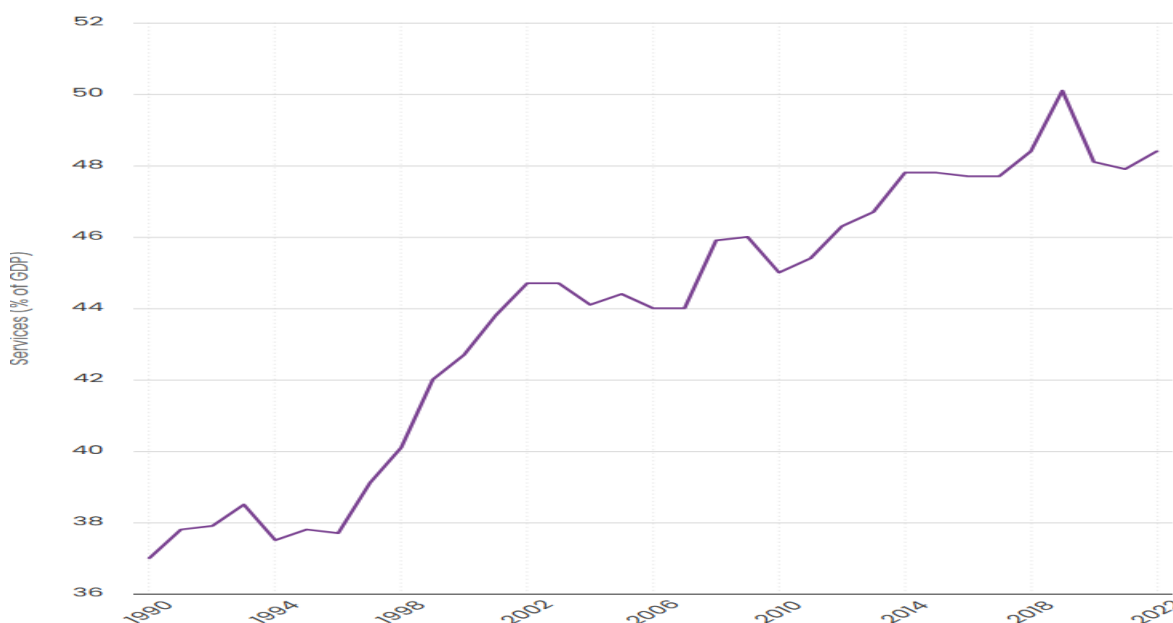


Fig. 1 - Services Sector Contribution to GDP in India (1990-2022)
